**INVITATION TO BID FOR THE PROCUREMENT PROJECT
ON THE CONSTRUCTION OF THE CES RESOURCE CENTER**

The Career Executive Service Board through the Government of the Philippines intends to apply for calendar year 2013 the sum of Pesos: Seven Million Four Hundred Forty-Five Thousand Eight Hundred Thirty One and 22/100 Only (P7,445,831.22) being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement project on the Construction of the CES Resource Center at the Career Executive Service Board compound. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The CESB now invites bids for the procurement project on the Construction of the two-storey CES Resource Center at the CESB compound. Completion of the Works is required four (4) months from contract signing. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Career Executive Service Board and inspect the Bidding Documents at the address given below during office hours from 8:00 AM to 6:00 PM.

A complete set of **Bidding Documents** may be purchased by interested Bidders beginning on **7 February 2013** from the address indicated above and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Pesos: Six Thousand Only (6,000.00)

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

The Career Executive Service Board will hold a **Pre-Bid Conference** at the **CESB Training Room**, on **12 February 2013** at **10:00 AM** which shall be open to all interested parties.

Sealed Bids must be delivered to the address indicated above on or before **25 February 2013 at 1:30 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bids will be opened on 25 February 2013 at 2:00 PM in the presence of the bidders' representatives who choose to attend at the address indicated above. Late bids shall not be accepted.

The Career Executive Service Board reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
