RESOLUTION NO. 577

WHEREAS, Presidential Decree No. 1, as amended, mandates the creation of a Career Executive Service that shall provide government *"with a pool of well-selected and development-oriented career administrators who shall provide competent and faithful service"*;

WHEREAS, the Board issued Resolution No. 453, dated September 10, 2002, which provides for a Revised Policy on Original and Promotional Appointment to Career Executive Service (CES) Ranks;

WHEREAS, said Resolution also provides that in addition to the requirements for promotional appointment to CES ranks, a CESO IV shall be required to hurdle a screening process established by the Board prior to his/her entry to a senior CESO rank;

WHEREAS, on January 29, 2005, the Board successfully piloted the hurdle tool to a total of 24 CESO IVs who are candidates for promotion to CESO III;

WHEREFORE, foregoing premises considered, the Board **RESOLVES**, as it is hereby **RESOLVED**, to approve the said hurdle as the screening process for promotion to Senior CESO Rank III.
