OFFICE OF THE EXECUTIVE DIRECTOR,
CESB SECRETARIAT**

Resolution No.665

WHEREAS, Presidential Decree No. 1, as amended, created the Career Executive Service Board (CESB) to serve as the governing body of the Career Executive Service (CES) and mandated to promulgate rules, standards and procedures on selection, classification, compensation and career development of members of the CES;

WHEREAS, the CESB has a career component otherwise known as the CESB Secretariat, which shall not only provide the institutional memory and ensure continuity of the CESB programs and projects but shall likewise be responsible for the day-to-day operations of the CESB;

WHEREAS, the CESB Secretariat shall be headed by an Executive Director, who, as the Chief Executive Officer, exercises general supervision and control over the operations and assisted by a Deputy Executive Director, who assists the Executive Director in handling the day-to-day operations of the CESB Secretariat;

WHEREAS, the CESB Secretariat was headed by former Executive Director Mary Ann Z. Fernandez-Mendoza, who was appointed by her Excellency President Gloria Macapagal-Arroyo as Commissioner of the Civil Service Commission on May 5, 2006 and assisted by Deputy Executive Director Arturo M. Lachica;

WHEREAS, as a result of the vacancy in the position of CESB Executive Director after CSC Commissioner Fernandez-Mendoza assumed her new post, Deputy Executive Director Lachica, as the next-in-rank official, had assumed as Officer-In-Charge and has been signing documents for and in behalf of the Executive Director in accordance with Section 5, Rule VII of the Rules Implementing the Code of Conduct and Ethical Standards Implementing the Code of Conduct and Ethical Standards for Public Officers and Employees (RA 6713);

WHEREAS, there is a need to formally designate an Officer-In-Charge of the CESB Secretariat to ensure the smooth operations of the day-to-day activities of the CESB;

NOW THEREFORE, foregoing premises considered, the Board **RESOLVES** as it is hereby **RESOLVED**, to formally designate Career Executive Service Board (CESB) Deputy Executive Director Arturo M. Lachica as Officer-In-Charge (OIC) of the Office of the Executive Director in the meantime that Her Excellency President Gloria Macapagal-Arroyo has not yet appointed an Executive Director for the CESB.
