



DECLASSIFYING THE POSITION OF ONE (1) EXECUTIVE DIRECTOR IV AND CLASSIFIYING FOURTEEN (14) DIRECTOR II POSITIONS IN THE HOUSING AND LAND USE REGULATORY BOARD (HLURB) AS CES POSITIONS

Resolution No. 1346

WHEREAS, Article IV, Part II of the Integrated Reorganization Plan provides that the Board shall promulgate rules, standards and procedures on the selection, classification, compensation and career development of members of the Career Executive Service (CES);

WHEREAS, CESB Resolution Number 799, Series of 2009, defines the coverage of the CES, to wit: (a) the position is a career position; (b) the position is above Division Chief; and (c) the duties and responsibilities of the position requires the performance of executive and managerial functions;

WHEREAS, CESB Resolution Number 945, Series of 2011, clarified the coverage of the CES and has limited the coverage of the positions belonging to the CES to positions requiring Presidential appointments in harmony with the ruling of the Supreme Court in the case of CSC vs. CA and PCSO, G.R. No. 185766 and G.R. No. 185767;

WHEREAS, Executive Order No. 648 s. 1981 created the Housing and Land Use Regulatory Board (HLURB), then known as the Human Settlements Regulatory Commission, as the planning, regulatory and quasi-judicial instrumentality of the government for land use development;

WHEREAS, E.O. No. 648, Section 6, (a) (ii) in relation to Section 6, (b) provided for the appointment by the President of the Chief Executive Officer of the HLURB for a fix term of six (6) years;

WHEREAS, the Chief Executive Officer referred to in E.O. No. 648 is the Executive Director IV reflected in the DBM approved plantilla of the HLURB;

WHEREAS, E.O. No. 648 does not provide for the appointing authority of the Director II positions in the HLURB;

WHEREAS, the appointing power of the Chief Executive Officer pursuant to E.O. No. 648, Section 7, (b) is limited to technical, legal and administrative staff of the HLURB;

WHEREAS, Article 7, Section 16 of the 1987 Constitution provides for the appointment by the President of all other officers of the Government whose appointments are not otherwise provided by law and those whom he may be authorized by law to appoint;

WHEREAS, Book IV, Chapter 10, Section 16 of E.O. No. 292 provides for the appointment by the President of Directors and Assistant Directors of Bureaus, Regional and Assistant Regional Directors, Department Service Chiefs, and their equivalents in accordance with law, rules and regulations;

WHEREAS, a study on the functions of the Director II positions reveals that these positions perform executive and/or managerial functions, are above Division Chief level, and are not for a specified term or coterminous; hence, are CES positions;

NOW, THEREFORE, the Board hereby RESOLVES, as it hereby RESOLVED, to declassify one (1) Executive Director IV position and classify the following fourteen (14) Director II positions of the HLURB as CES positions:
