CLASSIFYING THE EXECUTIVE DIRECTOR V AND ONE (1) DIRECTOR IV POSITION IN THE PUBLIC-PRIVATE PARTNERSHIP CENTER (PPPC) AS NON-CES POSITIONS AND TWO (2) DEPUTY EXECUTIVE DIRECTOR V, FIVE (5) DIRECTOR IV, AND FOUR (4) DIRECTOR III POSITIONS THEREIN AS CES POSITIONS

WHEREAS, Article IV, Part II of the Integrated Reorganization Plan provides that the Board shall promulgate rules, standards and procedures on the selection, classification, compensation and career development of members of the Career Executive Service (CES);

WHEREAS, CESB Resolution Number 799, Series of 2009, and CESB Resolution Number 945, Series of 2011, exclude from the coverage of the CES managerial and executive positions in the national government belonging to the closed career systems;

WHEREAS, Executive Order Number 8, Series of 2010 reorganized and renamed the Build-Operate and Transfer (BOT) Center into the Public-Private Partnership Center (PPPC) and transferred its attachment from the Department of Trade and Industry (DTI) to the National Economic and Development Authority (NEDA);

WHEREAS, Executive Order Number 136, Series of 2013 amended certain sections of Executive Order Number 8 for a more efficient implementation of PPP programs and projects;

WHEREAS, the Executive Director V position in the PPPC is subject to the appointing authority of the President per Section 30 of Executive Order Number 8, Series of 2010;

WHEREAS, appointment to the Executive Director V position in the PPPC is coterminous in nature;

WHEREAS, Section 3(b) of CESB Resolution Number 945, Series of 2011 excludes positions that belong to the non-career service from the coverage of the CES;

WHEREAS, the Executive Director V position in the PPPC, as a non-career position, is beyond the coverage of the CES;

WHEREAS, Executive Order Number 8, Series of 2010 and Executive Order Number 136, Series of 2013 do not expressly provide for the appointing authority for the Deputy Executive Director V, Director IV, and Director III positions in the PPPC;

WHEREAS, Section 16, Article VII of the 1987 Constitution vests in the President the authority to appoint "all other officers of the Government whose appointments are not otherwise provided for by law, and those whom he may be authorized by law to appoint";

WHEREAS, the Deputy Executive Director V, Director IV, and Director III positions are subject to the appointing authority of the President;

WHEREAS, all of these positions have Salary Grades (SG) above SG 25;

WHEREAS, the Job Profiles of the Deputy Executive Director V, Director IV, and Director III positions all require the exercise of executive/managerial functions;

WHEREAS, with the exception of the Director IV position with Item No. DIR4-8-2011, appointments to these positions are not coterminous in nature or subject to a term;

WHEREAS, consequently, said positions, with the exception of the Director IV position with Item No. DIR4-8-2011, are within the coverage of the CES;

WHEREAS, appointment to the Director IV position with Item No. DIR4-8-2011 is coterminous in nature and, following Section 3(b) of CESB Resolution Number 945, such position is beyond the coverage of the CES;

NOW, THEREFORE, the Board hereby **RESOLVES**, as it hereby **RESOLVED**, to declare the following positions in the PPPC as non-CES positions:
